Museum

Historian Rondus Miller discussed the progress of the grant funding and plans for the Accessible ramp and rear entrance door with the Board.

Minutes

The Minutes for the March 28, 2018 will be accepted with a change that notes that wages for Billy Rose is paid equal to Mark Morley, minus the amount of the wages paid for Water duties, until Mr. Rose finishes his water license accreditation. Councilman Hopkins made the motion. Councilman Austin seconded. 3 ayes. 0 noes.

The Minutes for the April 11, 2018 will be accepted with a change that notes that the motion was made to pay for the tractor; not purchase the tractor. The motion was made by Councilman Hopkins, seconded by Councilman Austin.

Highway

Superintendent of Highways discussed road work along and the paving Ballard Road.

Councilman Hinz joined the meeting at 7:30PM.

Superintendent Peet stated CHIPS money has come in at \$180,472.26 come in at \$29,000 for Pave NY Program.

The tractor that was sent to action brought in \$7,740.00. Motion to move the money from savings to the DA130.2 account was made by Councilman Austin. Seconded by Councilman Hopkins. 4 ayes. 0 noes.

A request was made to move the amount of an insurance payment for the Highway Superintendent's truck repair for \$3,033.22 to the DA5130.4 account.

The 1997 Kubota needs a lot of work. It will have to be replaced soon. It was suggested that it be budgeted for next year.

The 2005-2006 John Deer has a lot of hours on it.

He suggested that it be budgeted to replace both machine with one.

A truck should be in the next in line for large purchases for possible purchasing during the 2019-2020 budget year.

Superintendent Peet spoke with the Engineer for the County about Higgins Creek Road erosion problems. It was suggested that the road moved over 12-15 feet or use the old County Road.

Law

Attorney David Pullen discussed new tax laws that are being put into place for property tax.

Councilman Hopkins moved to adjust St. Patrick's Rectory account due to a leak. He moved to charge the full amount for the water consumed and \$150.00 for Sewer. Councilman Hinz seconded. 3 ayes. 0 ayes. Councilman Austin abstained.

Mowing

Councilman Austin moved to accept seal bids for mowing at a May 23, 2018 meeting. Councilman Hopkins seconded the motion. 4 ayes. 0 noes.

Councilman Austin is to put together a bid packet.

Bill and Reports

Councilman Austin motioned to accept the Clerk's Monthly Report and all bills as written. Councilman Hinz seconded. 4 ayes. 0 noes.

Adjournment

Councilman Austin motioned to adjourn the meeting at 10:15PM. Councilman Hopkins seconded. 4 ayes. 0 noes.
