Upon request from the Board, Superintendent Peet will be adding limestone in the parking lot by the mobile station.

Dog Control

Dog Control Leslie Clagett requested permission for an enumeration of the Town of Hume dogs. Councilman Hopkins motioned to move forward with the enumeration. Councilman Miller seconded. 5 ayes, 0 noes.

Water/Sewer Cont.

The Board asked Attorney David Pullen to amend to the already existing Water/Sewer Law by adding language stating that sump pumps cannot be emptied into the sewer system.

Councilman Austin motioned to accept and move forward with the maintenance schedule suggested in the study done by MRB. Councilman Hopkins seconded. 5 ayes. O noes.

Supervisor

Supervisor Mason shared with the Board that Ashley Smith contacted her with potential for a grant that is available thru the DEC to armor the Genesee River. A second round will be available to apply for next year.

Supervisor Mason shared that the Greenway Grant is nearing its completion.

Supervisor Mason requested that a Budget Workshop be advertised for August 29th at the Town of Hume Museum, 10892 Claybed Road at 6:30PM.
