February 13, 2019

A regular meeting of the Hume Town Board, Fillmore, New York, Allegany County, was held at 7 PM at the Wide Awake Club Library, 22 North Genesee Street, Fillmore, New York on February 13, 2019. Officials in attendance were Supervisor Darlene Mason; Councilmembers Daniel Miller, Bruce Hinz and Peter Hopkins; Superintendent of Highway Kevin Peet and Town Clerk Susan Bodnar.

Call to Order

The meeting was called to order at 7:05PM due to bad weather. Supervisor Mason called the meeting to order by reciting the Pledge of Allegiance.

Medical Insurance

Dan Bottsford of Bond Benefits Consulting was in attendance to inform the Board of the health insurance policies available for 2019 for the Highway Superintendent and Town Clerk.

Townwide Insurance

Steve Peck from Ryan Agencies to introduced a proposal for Townwide Insurance Coverage for 2019.

Minutes

Councilman Peter Hopkins motioned to accept the minutes, as written, of the January 9th, 2019 meeting. Councilman Miller seconded the motion. 4 ayes. O noes.

Bid Opening

The opening of bids for Fuel began at 7:30PM. Rinker Oil was the only Fuel bid given. The bid was rejected due to unclear pricing. Councilman Hopkins motioned the reject the bid. Councilman Hinz seconded. 4 ayes. 0 Noes.

Councilman Hopkins motioned to advertise for bids once again. Councilman Miller seconded the bid. 4 ayes. 0 noes.

Water/Sewer

Billy Rose was present to report to the Board that his Water Class D Licensing was completed through the Town of Caneadea Water Plant.

Highway

The Board approved to an added \$672.53 increase for the pricing of the John Deer 2025 Tractor that was approved from last Board meeting. Councilman Austin motioned to accept the increase. Councilman Hopkins seconded. 5 ayes. 0 noes.

Councilman Hinz motioned accept the purchase a John Deer 2-345 Zero Turn mower for \$3038.10 for cemetery work. Councilman Austin seconded the motion. 5 ayes. 0 noes.

Councilman Austin motioned to go ahead to have heat detectors installed in the Highway Garage for \$4,245.00, with an annual fee of \$399.00 for a monitoring call service. Councilman Hopkins seconded. 5 ayes. 0 noes.

There was discussion about replacement for the Ford F550 Pickup.

The fire hall has experienced a frozen septic line from the septic tank to the sewer line.

The Town has hired Corey Potter as an Independent Contractor through LiveWire Electric for \$25.00 an hour to consult with about the Water System. Councilman Hinz motioned to hire Mr. Potter, with the stipulation that he add the Town as a rider on his business insurance. Councilman Miller seconded. 5 ayes 0 noes.

There will be a meeting on February 22, 2019, that Supervisor Mason will be attending, with Allegany County to discuss possible grant opportunities for the Sewer District.
