The lease will be for \$2000.00 a year, the Dirienzo,s will be responsible for all utilities,the town reserves the right to the parking lot and snowplowing. Councilman Austin made a motion to allow the Letchworth Trail Meeting Associates to have Lawyer Mark Woltag propose a 99 year lease of Lattice Bridge.Councilman Hopkins Seconded. 5 Ayes. 0 Noes.

8:00 Councilman Austin motioned to go into Executive Session for Personnel Matters. Councilman Hopkins Seconded. 5 Ayes. 0 Noes.

Councilman Hinz made a motion to sign 3 year contract with Allegany County to have Hume Highway Dept. plow the 12 miles total of county road as previous contract stated. The new contract raised the rate \$75.00 more per mile at \$3575.00 per mile. Councilman Austin Seconded. 5 Ayes. 0Noes.
