A second meeting for the Town of Hume Town Board, Allegany New York was held on April 23, 2014 at the Town of Hume Museum, 10842 Claybed Road, Hume, New York. Supervisor Dennis Ricketts called the meeting to order at 7:00 PM, leading the Pledge of Allegiance to the Flag. Officials in attendance: Supervisor Dennis Ricketts, Councilmembers Daniel Miller, Darlene Mason, and Bruce Hinz; Highway Superintendent Kevin Peet; Deputy Town Clerk Jane Stenzel and Town Clerk Susan Bodnar.

PUBLIC FORUM

James Fegley, addressed the Board about the Town Highway Department clearing the area in front of his property. He understands that the clearing needs to be done, but, the mess left behind , he feels, is deplorable. His neighbors are also upset, though were unable to make the meeting.

Superintendent Peet had not arrived at the meeting at that point, so the Board told Mr. Fegley that they would talk with Mr. Peet about the matter. Mr. Fegley said he appreciated it.

Darlene Mason, as a representative of Fillmore Fest, asked that the Board pay for a sign to advertise Fillmore Fest. It is a sign that can change the message and be used over. Due to absent members, the Board was unable to make a vote on the purchase.

The Fillmore Fest committee is pursuing the possibility of running a banner across State Route 19 between Howard Byer's building and Sweetwater Media's building.

The 2003 International Truck and Side Mower that were declared surplus at the April 9, 2014 meeting were sold at Mason's auction.

DOG CONTROL OFFICER

Clerk Bodnar reported our new dog control officer Leslie Johnson is doing well. She has started to call dog owners with delinquent licenses, and has dealt with a dog bite case.

Clerk Bodnar reported Historian Miller has done a wonderful job with our website; all the Board members need to look it over. Historian Miller also is putting finishing touches on the next issue of The Bee.

MINUTES

Superintendent Peet asked that the record show that the amount paid for the gravel purchased from Jay Cockle be changed from \$4.80 to \$5.00 a yard.
